Harvest has an immediate opening for a **Foreman**, reporting to the Manager, Operations. This is a permanent, remote camp position based out of Hay River Operations located 65km West of Rainbow Lake with air charter available via Edmonton, Alberta as per designated rotating shift schedule.

Key Responsibilities:

- Participate in the development, implementation and sustainment of our HSER program
- Develop site specific plans for each area to parallel corporate expectations.
- Engage HSERs resources to assist in achieving HOC expectations.
- Schedule and participate in operating area workshops to achieve competencies in all HSER related areas;
- Develop staff management of change knowledge and audit compliance.
- Schedule and participate in audit related activities of our operations to improve overall
 efficiencies.
- Develop and forward yearly plans/schedules.
- Input all audit action plans for completion and tracking into Incident Reporting/Audit Database;
- Participate in the development and execution of environmental remediation plans;
- Develop plans for each operating area;
- Plan, participate and lead emergency response efforts in your area;
- Schedule and conduct routine safety meetings for the area;
- Schedule and conduct safety/environmental inspections at facilities and wells;
- Assist with safety initiatives as appropriate.
- Conduct or participate in incident investigations within or outside area of control when needed.
- Respond to regulatory non-compliance issues and determine remediation actions required.
- Enforces adherence to Harvest and regulatory policy and procedures.
- Ensures reporting of environmental or safety incidents according to HSER protocols.
- Perform Day-to-day oversight of area production and associated properties.
- Monitor downtime and set reduction goals and objectives.
- Measure results and perform root cause analyses when necessary to resolve variances.
- Ensure completeness and accuracy of wellsite and facility data.
- Provide feedback on changes to volume targets for each property as needed.
- Support well reviews with operators (leads/field) and production engineers and ensure followup of assigned actions.
- Provide feedback to production engineer on "upgrades" or optimization techniques to increase production and/or reduce downtime.
- Develop field and area operating and capital maintenance budget.
- Complete group operating expense accruals monthly according to the assigned timeline.
- Lead, champion, and support area initiatives to lower OPEX.



- Engage fully into well servicing activities to provide your experience and ensure costs communicated daily through production engineering and well services.
- Ensure field costs are accurately categorized based on OPEX and CAPEX guidelines.
- Conduct day-to-day operation and ensure upkeep of facilities, roads, and pipelines.
- Oversee and coordinate operator work shift and vacation schedules.
- Co-develop a progression development program that will allow each field operator to manage their own development plans and contribute at their maximum potential.
- Establish goals and objectives for leads and operators.
- Conduct performance evaluations for employees and key field contractors.
- Work on establishing and maintaining good working relationships within the communities, municipalities and with the landowners where we operate.
- Ensure preventative maintenance plans, procedures and schedules are in place.
- Promote and support the development of field maintenance strategies that will facilitate the proper planning and execution of our maintenance activities.
- Management of scheduling and execution of turnarounds.
- Ensure management of change documents are completed, circulated, and filed in the appropriate location.
